Proof of Vaccination Protocol for Extracurricular activities including School Sports

Dear LT families,

We would like to inform families, that Nova Scotia is implementing a Proof of Vaccination Protocol for extracurricular activities effective Monday October 4, 2021. For School Sport Nova Scotia, this will mean people who are 12 and older must provide proof of vaccination to attend and participate in all indoor and outdoor extracurricular activities.

- Schools will be responsible for determining if our participating athletes meet vaccination requirements in advance of the activity.
 We will not maintain vaccination records.
- Children who turn 12 between January 1 and October 4, 2021
 have until December 31, 2021 to attend events and activities while
 they get vaccinated. Children who turn 12 after October 4, 2021
 have 3 months from their birthday to get vaccinated.
- Students 13 to 18 who have proof of receiving 1 dose of COVID-19 vaccine can participate in extra-curricular activities. To continue participating, these students must provide proof of full vaccination by November 9, 2021.

Spectators

- Parents / Spectators will need to show proof of vaccination at events.
- To facilitate the checking of vaccination status, events will have clearly identified entrances with individuals stationed at these entrances to verify proof of vaccination. For outdoor events with no fences, tables may be setup to check for proof of vaccination.
- For Spectators, Government Photo identification will be required to ensure that the vaccine record corresponds to the individual.

October 4th, Soccer games at Metropolitan Field

For our games taking place at Met Field, all spectators inside the fence area will be required to show a government photo ID and Proof of Vaccination.
